An Atheist Discusses Death

What happens when we die?

What happens to what? A prevailing thought is we have a soul, and it lives on after our death. I'm not aware of any Objective Evidence for the existence of a soul. If a soul doesn't exist, then it can't continue. "Death" is cessation of life, saying 'life after death' is like saying 'race after the finish line'. If you're still racing, then you haven't gotten to the finish line and if you passed the finish line whatever you're doing afterwards can't be the same race.
